By registering, attending, viewing or participating in a Celebrity event, it is agreed that your own insurance policy will be the only source of any reimbursement in case of injury or any other instance. You acknowledge Celebrity Competitions, Celebrity Dance Competitions, Celebrity Nationals at Sea, Celebrity Travel, Celebrity Conventions, Celebrity Media, Celebrity Carriers have the right to use any forms of media including but not limited to photographs and video in any and all promotional related materials indefinitely.

COVID-19 RELEASE

The novel coronavirus, COVID-19, has been declared a worldwide pandemic by the World Health Organization. COVID-19 is extremely contagious and is believed to spread mainly from person-to-person contact. Celebrity Competitions/Celebrity Conventions has put in place preventative measures to reduce the spread of COVID-19; however, Celebrity Competitions/Celebrity Conventions cannot guarantee that you or your child(ren) will not become infected with COVID-19. Further, attending Celebrity Dance in-person could increase your risk and your child(ren)'s risk of contracting COVID-19.

By signing this agreement, I acknowledge the contagious nature of COVID-19 and voluntarily assume the risk that my child(ren) and I may be exposed to or infected by COVID-19 by attending Celebrity Competitions/Celebrity Conventions in-person events, and that such exposure or infection may result in personal injury, illness, permanent disability, and death. Although Celebrity Competitions/Conventions has taken measures to keep all guests safe, I understand that the risk of becoming exposed to or infected by COVID-19 at an event may result from the actions, omissions, or negligence of myself and others, including, but not limited to, Celebrity Competitions/Celebrity Conventions employees, representatives, volunteers, other dancers and their families.

I voluntarily agree to assume all of the foregoing risks and accept sole responsibility for any injury to my child(ren) or myself, including illness, death, damages, loss, claim, liability or expense of any kind, that I or my child(ren) may experience or incur in connection with my child(ren)'s attendance at a Celebrity Competitions/Celebrity Conventions event. On my behalf, and on behalf of my children, I hereby release, covenant not to sue, discharge, and hold harmless Celebrity Competitions/Celebrity Conventions, its employees, agents, and representatives, of and from the claims. I understand and agree that this release includes any claims based on the actions, omissions, or negligence of Celebrity Competitions/Celebrity Conventions, its employees, agents, and representatives, whether a COVID-19 infection occurs before, during or after participation in a Celebrity Competitions/Convention event.

By signing you agree that you, any guests on this form, and your child(ren) are NOT experiencing the following symptoms:

- No fever for 2 weeks
- No cough
- No cold/flu symptoms such as chills, muscle pain, headache or sore throat
- No shortness of breath
- No loss of smell/taste
- No positive COVID-19 test
- No close contact with someone who tested positive for COVID-19 in the past 5 days
- No pending COVID-19 test results

Parties agree that any and all claims, causes of actions or lawsuits arising out of or relating to this agreement shall be litigated only in the state or federal courts sitting in Maricopa County, Arizona, and each party hereby submits to the exclusive jurisdiction of each of such courts for such purposes. In connection with any litigation arising from this Agreement, the prevailing party shall be entitled to recover all costs incurred, including but not limited to reasonable attorneys' fees for such litigation and any subsequent appeals. The parties waive any right to assert any claims against the other party as a representative or member in any class or representative action, except where such waiver is prohibited by law or deemed by a court of law to be against public policy.

The undersigned agrees to abide by all rules and regulations pertaining to Celebrity Competitions, LLC and companies that work with Celebrity Competitions, LLC and agrees to all terms and rules for their child(ren) and they are aware of all policies. The undersigned agrees all policies will be those of Celebrity Competitions/Celebrity Conventions and the laws of the state of Arizona only. Celebrity may change or adjust policies as needed.
